Upcoming Workshops

- **Advanced Forest Stewardship class - Spring 2009 in Everett, WA.** The Advanced Series is for all of you who have already taken Coached Planning and are looking to further expand your forestry knowledge. The goal of the class is to build on the knowledge you gained in Coached Planning and help you prepare to successfully implement on-the-ground operations as you carry-out your forest stewardship plan. We will be talking about things like forest inventory, equipment use, working with contractors, financial considerations, advanced silviculture techniques, log markets, taxes, road building and maintenance, and so forth.

This will be the second offering of this class (a pilot was offered this past fall). The series includes 9 evening sessions and 2 field days. The class will be held Monday evenings April 13th – June 8th at the Snohomish County Extension building in Everett. Cost is \$100 per family/ownership. - **Chainsaw Safety and Maintenance Workshop - June 13, 2009 in Everett, WA** Join us for a hands-on Chainsaw Safety and Maintenance workshop. Learn how to properly sharpen your saw, maintain peak performance, and avoid serious injuries. This workshop will be led by an expert safety educator from Stihl Northwest. Bring your saw (with no fuel in it). The workshop will be held from 9 AM to 12 PM at the Snohomish County Extension building at McCollum Park in

- **Healthy Forests for Fish and Wildlife – June 4, 2009 in Arlington, WA.** Got critters? If habitat for fish and wildlife is one of your forest ownership objectives, join us for this free workshop for family forest owners. Speakers from WSU Extension, DNR, WDFW, the Snohomish Conservation District, and the Sno-Stilly Task Force will be teaching about how to enhance wildlife habitat on your property, fish and aquatic habitat, and wildlife resources and funding opportunities for family forest owners. The workshop will be held on Thursday June 4, 2009 from 6 PM to 9 PM at the Loyal Heights Community Club just north of Arlington (Bryant neighborhood). - **Introduction to the Community Firewise Program and Wildland/Urban Interface Fire Safety: Monday, March 30th in Bow.** See the results of cooperation, coordination, and pre-planning in Skagit County Fire District #5. Welcome, King County

As most of you King County folks are probably aware of at this point, King County Extension Forester Amy Grotta has accepted a position with the Oregon State University Extension program. Her departure is not the result of any program cuts by King County or WSU, but rather it is a wonderful new opportunity for her to pursue. In the meantime, because of hiring freezes at the state and county level, filling her position would be challenging right now, and we want to continue to provide services to King County forest owners without interruption.

The solution that made the most sense, at least in the short term (2009), was to expand my coverage (which was formerly just Snohomish and Skagit Counties) southward to also include King County. How this will play out in the long term (2010 and beyond) remains to be seen. With budgets the way they are, I think regionalization of programs (as opposed to county-specific) is going to be the wave of the future.

Please be assured that these changes do not mean the end of, or even the interruption of, the King County Forest Stewardship Program. I will be working to provide the same programming that Amy was providing, including a Coached Planning class in Fall City this fall, and other forestry workshops. Ginny Ballard, program coordinator for WSU King County Extension, will be providing much needed and appreciated assistance with these workshops. Both Ginny and I are available as resources to King County forest owners, just as Amy has been.

Seedlings and native plants still available

We're getting near the end of planting season, but there are still plants and seedlings available for last-minute projects. Here are some upcoming tree and plant sales:

- **The Whatcom Chapter of the Washington Farm Forestry Association** will be having a seedling sale 3 – 5 PM **Friday, April 3, 2009** at Com-Steel, 2321 East Bakerview Rd, **Bellingham**. Also, rumor has it that Fourth Corner Nursery in Bellingham suddenly has many thousands of bare root trees and shrubs available due to a large planting project that got put on hold this spring. The plants need to be planted this spring and include red alder, black cottonwood, paper birch, Douglas-fir, western redcedar, western hemlock, shore pine, grand fir, Sitka spruce, red-osier dogwood, and others. Funding Opportunities

There are several current funding opportunities available for family forest owners:

- **Pioneers in Conservation grants** – “Pioneers in Conservation grants are intended to help farmers and foresters protect and restore salmon habitat in a manner that is both environmentally sustainable for fish and economically sustainable for farm or forest businesses.” Eligible projects must solve a discreet salmon habitat issue and forestry or agriculture issue. Matching funds are required. **Application Deadline is Tuesday March 31, 2009.** For application details visit <http://www.nfwf.org/pioneers> or call 503-417-8700.

- **Wildlife Habitat Incentives Program (WHIP)** – “WHIP is a national program administered by the NRCS that provides technical and financial assistance to private landowners and tribes for developing, restoring and enhancing fish and wildlife habitat. Landowners receive technical and financial assistance through five- to ten-year contracts.” **Application deadline is April 15, 2009.** Interested landowners should contact their local NRCS office (see phone numbers below).
- **Environmental Quality Incentives Program (EQIP)** – This program is likely to be relevant to many of you. The program provides landowners with funding to carry out stewardship activities such as tree planting, vegetation control, pre-commercial thinning, pruning, road maintenance, and more. If you have been wanting to undertake some projects to keep your forest healthy and vigorous but have not been able to cover the costs, please consider this program! We would love to see some of these funds utilized locally. **Application deadline for 2010 funds is July 15, 2009.** For more information visit <http://www.wa.nrcs.usda.gov/programs/eqip/forestry/index.html> or contact your local Natural Resources Conservation Service (NRCS) office (see phone numbers below).

WSU Budget Update

At this point, the budget is in the hands of the Legislature. Yesterday's budget announcement from the state senate included a \$500 million cut to universities statewide. More specific information about what will be cut should be coming soon.
