## **Upcoming WSU Extension Forestry Workshops**

- **2010 Country Living Expo – Saturday January 30, 2010.** The Expo will be held at Stanwood High School from 7:30 AM – 5:00 PM. Over 100 different classes are offered on a variety of different topics from livestock to gardening to cheese making, with a whole lot in between. We even have some forestry sessions (taught by yours truly). - **2nd Family Forest Expo – Saturday February 13, 2010** at Green River Community College in Auburn. Think of this as a “mini-field day” with a variety of indoor and outdoor classes and demonstrations. Attend up to seven different expert presentations, choosing from more than two-dozen topics, including tree and shrub ID, wildlife ID and

management, forest insects and diseases, forest management, tree-pruning, and fire-wise practices. Demonstrations will include small-scale equipment, tool use, and tree falling. There also will be a resource area featuring equipment vendors, and public, private, and nonprofit organizations that provide assistance to landowners.

Advance registration received by Feb. 8 is \$40 per family. Registration at the door is \$60 per family. Box lunches will be available for an additional \$10 each. Because there are no restaurants or stores in the immediate area, attendees are encouraged to either sign up for the box lunch or to plan to bring their own.

- **Ties to the Land – March 11 and April 1, 2010** - Family forest and farm owners and invited to attend the award-winning Ties to the Land estate planning workshop. This two-part class will be held Thursday March 11 and April 1 from 6 – 9:30 PM at Hadley Hall (Arlington Boys and Girls Club) in Arlington. It is never too early to develop an estate plan (but often too late!) Planning the long-term future of your land is perhaps the single most important thing you can do as a land steward, whether of forestland, farmland, or ranchland. Your land will outlast you, but you can take steps now to ensure that it has a positive future. “Failing to plan is planning to fail.” This class will give you practical tools for communicating with family members, identifying goals and options, and putting together a team of professionals to help you. New this year: we will include a panel of local estate planning professionals for a Q&A discussion.
